Please be advised we require the following:

- Auto/General Liability – A combined single limit of not less than 1 million.
- Bodily Injury/Property Damage for hired/non-owned. If less than 1 million, show excess/umbrella coverage.
- Bahri must be named as additional insured for both auto & trailer interchange.
- Trailer Interchange including collision – Not less than \$25,000 per vehicle (this collision coverage is for our equipment). "Including collision" must appear on certificate.
- 30 day cancellation notification required.

In the event that you do not carry this limit you MUST send:

A letter (on your letterhead) advising that you will self-insure Trailer Interchange including collision for the difference between the Insured Amount and \$25,000 and must be signed by a company officer.

A copy of current letterhead.

PLEASE NOTE: This is a temporary interchange agreement good for 30 days only. Upon receiving the truckers signed copy, the trucker will be mailed or emailed a Permanent Interchange Agreement. If Bahri does not receive a signed copy of the Permanent Interchange Agreement back within 30 days, the agreement will be Null and Void and Bahri will NOT issue another temporary interchange agreement.

UPON RECEIPT OF ALL OF THE ABOVE, BAHRI WILL APPROVE YOUR MOVEING OUR EQUIPMENT.

SCHEDULE A – Use Charges

1. Free Time:

Import

- a. Regular Equipment: Day of Interchange plus 5 (five) days, excluding Saturdays, Sundays and Holidays.
- b. Refrigerated/Tank Equipment: Day of Interchange plus 3 (three) days, excluding weekends and Holidays.
- c. Trailers other than standard flatbeds, all types/sizes: Day of Interchange plus 4 (four) days, excluding Saturdays, Sundays and Holidays.

Export

- a. All Equipment: Day of Interchange plus 22 days including weekends.

2. Charges

- a. Use charges shall be charged for the first 5 calendar days following free time as follows:

Open Tops:	20' Open Tops	\$70.00 Per Day
	40' Open Tops	\$80.00 Per Day

High Cubes:	40' 9'6" Units	\$70.00 Per Day
Trailers other than flatbeds:		\$100.00 Per Day

- b. Use charges shall be charged for additional days commencing with the 6th calendar day following free time as follows:

Regular Equipment:	Standard 20'	\$80.00 Per Day
	Standard 40'	\$110.00 Per Day
Open Tops:	20' Open Tops	\$120.00 Per Day
	40' Open Tops	\$140.00 Per Day
Flat-racks:	20' Flat-racks	\$120.00 Per Day
	40' Flat-racks	\$140.00 Per Day
High Cubes:	40' 9'6" Units	\$110.00 Per Day
Trailers other than flatbeds:		\$200.00 Per Day
